1. Health & Safety Commitment

- Emergency preparedness with evacuation procedures and safety equipment
- Safety training for all workers in their native language

- Safe handling and storage of hazardous materials with training
- Machine safety protocols with proper guarding and maintenance
- Ergonomic workplace design to prevent repetitive strain injuries
- Monitoring and tracking of accidents, injuries, and near-misses
- Special protection for vulnerable workers and those with disabilities
- Safe and hygienic worker accommodation when provided
